2. After careful perusal of all the papers and affidavits submitted by your School Management and taking into account the recommendations of the Distt. Education Officer, Ferozpur and DPI Private Aided Schools, the Govt. of Punjab is issuing "No Objection Certificate" on the following conditions:

1. In future, on any complaint/inspection, if it is found that the school has submitted a wrong information to get the "No Objection certificate" or the school is not complying with the directions of the Punjab Govt. issued from time to time and the school is not obeying the written conditions given in the affidavit in that case the "No Objection Certificate" issued to you can be withdrawn.
2. It will be compulsory to teach Punjabi up to Matric level (10<sup>th</sup>) in your school, and the C.B.S.E will make compulsory necessary arrangements to take the examination of Punjabi subject in these schools and with this it is made clear that the 'No Objection Certificate' can be withdrawn if the school fails to comply with the directions.
3. The school management will pay the salary and other allowances to its teaching and non-teaching staff as per the Govt. employees after taking the affiliation with C.B.S.E. In case of non-compliance of this the 'No Objection Certificate' can be withdrawn.
